## CONFIRMATION OF TREASURY SHARES HELD

At 31 December 2024, the Group holds a total of 6,925,889 shares in treasury. This includes 5,686,373 shares held directly by subsidiaries and 1,239,516 shares held in separate broker accounts for employees. The shares held in employee broker accounts relate to share awards in terms of the Thungela share plan which have not yet vested. These shares are considered treasury shares for Thungela until the awards have vested, in line with the rules of the Thungela share plan.

The 5,686,373 treasury shares held directly by subsidiaries do not carry voting rights.

The total number of ordinary shares in issue which carry voting rights amounts to 134,806,212.
